Description

The TIR-4IT Infrared Hand-held Remote Control provides four lighting scenes, remote dimming, and switching from the palm of your hand. The Infrared Hand-held Remote Control transmits signals (up to 9 metres) to a Telume™ Dimmer. The Infrared Hand-held Remote Control is compatible with other learnable remote controls.

The Infrared Hand-held Remote Control is safe for use around baths and spas.



Battery Replacement

The Infrared Hand-held Remote Control uses 3 AAA batteries that are pre-installed (see diagram). For best results use *Energizer*_® brand alkaline batteries. Do not use NiCad batteries. Removal of batteries will not affect the scene programming of your Telume_™ Dimmers.

To replace batteries:


- 1. Remove the battery cover.
- 2. Replace with 3 size AAA alkaline batteries as shown.
- 3. Replace the battery cover.



TIR-4IT Infrared Hand-held Remote Control

Operation

Point the Infrared Hand-held Remote Control at the Telume™ Dimmer, not an Accessory Dimmer, then use the Scene Buttons and Rocker as shown below.



Easy Scene Programming

- 1. Adjust Telume™ Dimmer(s) to desired light level.
- 2. Point the TIR-4IT at the Telume™ Dimmer(s).
- Press and hold corresponding scene button until the Dimmer's LEDs flash (approximately 4 seconds). Scene is set.
- 4. Repeat steps 1 through 3 for all scene buttons.

Troubleshooting

Problem	Causes	Remedies
Infrared Hand-held Remote Control has no effect on the Telume™ Dimmer.	Power to the Dimmer is turned OFF.	Restore power.
	Batteries are exhausted, weak, or not installed in the Infrared Hand-held Remote Control.	Install new batteries.
	Infrared Hand-held Remote Control is too far away from the Telume™ Dimmer.	Move to within 9 metres of the Telume™ Dimmer.
	Batteries inserted incorrectly.	Install batteries per diagram.
Lighting scene does not change when programmed.	Scene button is not held until the LEDs on the Telume™ Dimmers blink (approximately 4 seconds).	Hold scene button until LEDs on Telume™ Dimmers blink.
	Infrared Wireless Remote Control is not pointed at the Telume™ Dimmers when setting or recalling scenes.	Point the Infrared Hand-held Remote Control directly at the Telume™ Dimmers when storing and recalling lighting scenes.
